A RESOLUTION SETTING THE DATES AND TIMES TO PERMIT THE DISCHARGE OF CONSUMER FIREWORKS.

- **WHEREAS,** After review of this year's calendar and the days of the week it is in the City's best interest to establish permitted dates and times for the fourth of July holiday;
- WHEREAS, The permitted dates and times for 2020 shall be Friday July 3, 2020 and Saturday July 4, 2020, from noon until 11:00 p.m. on both days so long as all other conditions set out in Section 4.50.060 regarding the discharging of fireworks are complied with; and
- **WHEREAS**, it is in the best interest of the City of Council Bluffs to authorize the discharge of consumer fireworks during these permitted dates and times.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COUNCIL BLUFFS, IOWA

That the discharge of consumer fireworks are permitted on Friday July 3, 2020 and Saturday July 4, 2020, from noon until 11:00 p.m. on both days so long as all other conditions set out in Section 4.50.060 regarding the discharging of fireworks are complied with.
