RESOLUTION NO. 20-18

A RESOLUTION TO VACATE AND DISPOSE OF AVENUE M RIGHT-OF-WAY LOCATED BETWEEN NORTH 8TH AND NORTH 10TH STREETS, AND ABUTTING PROPERTIES LEGALLY DESCRIBED AS LOTS 2 AND 3, BLOCK 8, TURLEY'S ADDITION AND LOTS 2 THROUGH 5, BLOCK 7, TURLEY'S ADDITION ALONG WITH THE VACATED ALLEY ADJACENT, CITY OF COUNCIL BLUFFS, POTTAWATTAMIE COUNTY, IOWA.

WHEREAS, following public hearing and having given careful study to the proposal, the City Council determines that city-owned right-of-way described as follows: Avenue M right-of-way located between North 8th and North 10th Streets, and abutting properties legally described as Lots 2 and 3, Block 8, Turley's Addition and Lots 2 through 5, Block 7, Turley's Addition along with the vacated alley adjacent, City of Council Bluffs, Pottawattamie County, Iowa; and

WHEREAS, a public meeting was held on this matter on the 27th day of January, 2020; and

WHEREAS, pursuant to Iowa Code Section 354.23, the City Council declares its intent to dispose of this City right-of-way by conveying and quitclaiming all of its right, title, and interest in it to the abutting property owner(s); and

WHEREAS, this conveyance is subject to the reservation of a permanent and perpetual utilities easement of way in favor of the City of Council Bluffs, for the maintenance of any and all utilities equipment presently in place, and for such reconstruction, re-emplacement and repair thereof which said City and its licensees and/or franchise grantees may in the future deem necessary and proper, and for the removal of any improvements emplaced thereon by the grantees, or their successors or assigns, necessitated by the reconstruction, re-emplacement, or repair of such utilities, such removal to be at the sole expense of grantees or their successors or assigns and without cost to the City, its licensees and/or franchise grantees, and without obligation to repair or replace such improvements, and subject to any and all other easements and right-of-way of record and those not of record.

**NOW, THEREFORE, BE IT RESOLVED
BY THE CITY COUNCIL

CITY OF COUNCIL BLUFFS, IOWA**

That the above-described city right-of-way is hereby vacated and conveyed as follows:

Richard L. Mowery Jr. and all successors in interest: The South ½ of vacated Avenue M abutting Lots 4 and 5 and the North ½ of the vacated east/west alley adjoining, all in Block 7, Turley's Addition, for the total sum of \$479.08.

Randall Mowery and all successors in interest: The South ½ of the vacated Avenue M abutting Lots 1 through 3 and the North ½ of the vacated east/west alley adjoining, all in Block 7, Turley's Addition, for the total sum of \$402.92.

Clinton M. Mowery and all successors in interest: The North ½ of the vacated Avenue M abutting Lots 2 and 3, Block 8, Turley's Addition, for the total sum of \$796.97.

BE IT FURTHER RESOLVED

That the Mayor and the City Clerk be and are hereby authorized, empowered and directed to execute a City deed conveying the City's interest in the above-described right-of-way; and

BE IT FURTHER RESOLVED

That the City Clerk is directed to deliver this resolution and attached documents to the County Recorder according to Iowa Code Section 354.23.
