SUBJECT: Title 16: Historic Preservation

The 2024 Council Bluffs Historic Preservation Commission Work Plan identified updating Title 16: Historic Preservation of the Council Bluffs Municipal Code as one of the seven work projects for the year. Over the past year, the Title 16 Subcommittee has analyzed the existing ordinance, researched best practices, and drafted an updated Title 16 for your review.

Much of the language from the current Title 16 has remained. The primary areas of proposed updates to the Title aim to:

- Provide greater clarity on preservation terminology utilized within the ordinance;
- Establish standards for review of exterior modifications;
- Create additional opportunities for preservation through new context sensitive tools; and
- Establish a review process for demolitions of historic structures.

Please review the attached draft ordinance and be prepared to discuss any edits and/or suggestions during the November Historic Preservation Commission meeting. The intent is to begin meeting with relevant neighborhood organizations on the proposed updates in early 2025.
